



2020 Year-End Capital Gain Indications

Preliminary capital gains distribution indications (shown as a percentage of net asset value) are based on each fund's portfolio at a point in time and are subject to change prior to each fund's actual distribution. Actual distributions will be based on net capital gains and losses realized by each fund through October 31st and may be substantially different.

Each fund's short-term and long-term capital gain distributions are the same for all share classes. Ordinary income distributions may vary among share classes.

This preliminary information IS NOT FINAL. Tax returns should not be prepared based on this information. Shareholders should contact their tax advisors for information regarding the federal and state income taxation of capital gain distributions on their personal tax situations.

Indications do not include ordinary income distributions, other than short-term capital gains, a fund may be making. Net short-term capital gains, when distributed, are generally taxable as ordinary income and are reported as Ordinary Dividends on Form 1099-DIV.
