Investment Overview

Provides a portfolio of at least 80% municipal securities, and at least 80% investment-grade securities, with an average maturity of between 3 and 10 years. Seeks high current income exempt from Federal income tax. Emphasizes team management and extensive credit research expertise to identify attractively priced securities.



Portfolio Data Information

Credit Quality is a measure of a bond issuer's ability to repay interest and principal in a timely manner. The credit ratings shown are based on each portfolio security's rating as provided by Standard and Poor's, Moody's Investors Service and/or Fitch Ratings, Ltd. and typically range from AAA (highest) to D (lowest), or an equivalent and/or similar rating. For this purpose, if two or more of the agencies have assigned differing ratings to a security, the highest rating is used. Securities that are unrated by all three agencies are reflected as such. What should I know before investing?

Glossary

Average Life: An estimate of the number of years to maturity, taking the possibility of early payments into account, for the underlying holdings. Effective Duration is a duration calculation for bonds with embedded options. Effective duration takes into account that expected cash flows will fluctuate as interest rates change. Duration measures the sensitivity of price (the value of principal) of a fixed-income investment to a change in interest rates. The higher the duration number, the more sensitive a fixed-income investment will be to interest rate changes. AMT Exposure measures the percentage of a fund's assets invested in bonds with income subject to the alternative minimum tax (AMT). Average Coupon is the average interest rate stated on the securities held by a portfolio. Average Coupon is calculated without the deduction of fees and expenses.
