While the Fund intends to conduct quarterly tender offers for up to 5.0% of the aggregate NAV of its common stock then outstanding as of the date stated in the Fund's Offer to Purchase in the sole discretion of its Board of Directors, it is not obligated to do so. Repurchases will be made at such times and on such terms as may be determined by the Board, in its sole discretion. Accordingly, there may be quarters in which no tender offer is made, and it is possible that no tender offers will be conducted by the Fund at all.

There is no guarantee that an investor in the Fund will be able to sell all common stock that the investor desires to sell in a tender offer. Due to these restrictions, an investor should consider an investment in the Fund to be illiquid.
