

Instruction to Terminate Custodianship

IMPORTANT INFORMATION:

- Use this form to terminate a custodianship established under the applicable UGMA/UTMA law and to register the securities to the sole name of the former minor, who has reached the applicable UGMA/UTMA age of termination.
- The former minor must complete and sign an Account Application.
- Proof of age is required (copy of birth certificate, valid driver's license, or valid passport) if this termination form is signed by the former minor.
- If the former minor's legal name has changed, please include the previous and new names in Section 2B and have the signature in Section 4 notarized.
- Online access for the account(s) will be removed upon termination of custodianship. The former minor will need to register for online access on
- Return any issued share certificate(s). We recommend returning certificates by a traceable method of delivery (i.e., express, certified or registered mail, etc.). If any outstanding share certificates are returned to us, the certificates will not be reissued. Franklin Templeton does not issue new share certificates.
