The Fund paid a regular quarterly distribution of \$0.212672 per share for Class I on December 20, 2024. Based on the Fund's fiscal year-to-date activity and subject to revision, the Fund currently estimates that \$0.078848 of the distribution for Class I may be a return of capital. The balance of the distribution is derived from undistributed net investment income.

This information is being provided pursuant to Section 19(a) of the Investment Company Act of 1940, as amended, and should not be used for tax reporting purposes. In early 2025, after definitive information is available, the Fund will send shareholders a Form 1099-DIV specifying how the distributions paid by the Fund during calendar year 2024 have been characterized for purposes of reporting the distributions on a shareholder's tax returns.
